1.	Applicant must be a citizen of India.

4.	The eligibility of the candidate in terms of qualifications/ experience, etc. shall be considered as on the date of the written test/interview. Before submitting the online application, the candidate must ensure that he/she fulfills all the eligibility criteria for the post for which she/he is applying as

	detailed for the respective post. Candidates will be allowed to attend the written test based on the information provided by them in their online applications. If at any subsequent stage, the information provided/claim made by the applicant is found to be false, <u>his / her candidature will be canceled at any stage of the recruitment process and if appointed, services will be terminated without any notice or compensation.</u>
5.	The applied candidates are required to attend the written test on 27-05-2024 from 10:00 AM onwards, reporting time for the written test is 09:00 AM on 27-05-2024 . The candidates qualified in the written test are required to attend further selection process/interview, subject to verification of all original certificates before the interview. The candidates are advised to carry all original certificates along with one photocopy.

The appointment shall be on a purely temporary basis for 11 months, and further extension of tenure, if any, may be granted subject to the satisfactory performance of the selected candidate and the requirement of the Institute. The appointment will be on contract basis and can be terminated at any time during the contract period with one month's notice from either side. Accordingly, no right/claim whatsoever will confer on the selected candidate(s) for employment in IITH by virtue of the above temporary engagement.
7.	Working Hours: 8 hours per day, 6 days a week during the period of the engagement. However, he/she is required to work during weekends/holidays as and when informed by the Head of the Department/ Faculty-in-Charge/ Chairperson. Campus residential accommodation will not be provided for the selected candidate.
8.	Educational qualifications prescribed in this advertisement must have been obtained from a recognized Board/Council/University/Institute.
10.	The Institute reserves the right to restrict the number of candidates for written / skill test/interviews to a reasonable limit based on qualifications, level and relevance of experience higher than the minimum prescribed in the advertisement and other academic achievements. The Institute also reserves the right to reject any or all the applications without assigning any reasons.
12.	The institute has the right to decide the mode of screening and testing the applicant for shortlisting and selection.
