It depends on the area of research and its relevance to Ocean Engineering. Also it is a department decision on the basic degree requirement since it involves teaching of basic courses in the concerned department

It depends on the area of research and its relevance to Mechanical Engineering. Also it is a department decision on the basic degree requirement since it involves teaching of basic courses in the concerned department
	6) If a candidate has more than 3 years of experience before PhD as Scientific Officer in ISRO/BARC, will he/she be eligible to apply for Assistant professor Grade-I post just after his PhD?	As per the Gol order, Those who have 3 years post Ph.D. experience will be considered for Asst. Professor Grade-I.
	7) Are the vacancies for Assistant Professor post released category wise (i.e., Open category - X no, OBC NCL - Y no, etc) or is there no category wise division for the posts?	Posts are not advertised as per category wise.
	8) If the vacancies are released category wise and if a candidate belongs to OBC-NCL and applies for Assistant Professor Grade- I open category post, will the upper limit of his age is considered as General or OBC-NCL category?	Age relaxation will be provided as per the Gol Norms.
