As stated in the advertisement 'the notified three vacancies includes two future vacancies anticipated up to 31st August 2020'. Further it was also stated in the advertisement that 'the number of posts actually filled may be less, if future vacancies do not materialize'. (copy of advertisement is enclosed). Accordingly, only one post got filled as per the requirement of the Institute duly following the criteria laid down in the advertisement.

Grounds of the appeal:

Provided Incomplete, Misleading or False Information

Appeal Text:

Kindly furnish the details as per the recruitment notification: IITH/2020/Rec/NF/8 for the post of Assistant Engineer(Civil)

1. Kindly furnish details of the marks obtained by the candidates appeared for the interview.

2.Kindly furnish the details of cut off marks in interview for the post of assistant engineer civil.

3.Kindly furnish the details whether 2 future vacancies are materialized as on today.

4.Kindly furnish the details of candidates who got selected for the 2 future posts which is materialized.

Disposal of Appeal:

- 1 & 2. Information sought under point no. 1 & 2 doesn't relate to your RTI application with Reg. No. IITHY/R/E/21/00028, dated.28/01/2020 as such it can't be qualified as appeal. However, answer to the point no. 1 & 2 has already been provided to you against your RTI application no. IITHY/R/E/21/00059 dated 02.02.2021.
