- 1) With reference to my RTI Application NO. IITHY/R/E/21/00104, dated 17/02/2021, the information sought i.e Answer Key of the Question Paper, has been denied by the CPIO citing the reason as,
- "Model answer scripts/key cannot be disclosed as it is not satisfying the larger public interest and the question bank used to prepare question paper is limited."

The reason so cited as above by the CPIO, doesn't hold any ground as such because the question Paper has already been provided by the CPIO in the RTI reply as well coming to the point of larger public interest, it is outlined that the information sought is essential for ensuring the spirit of Fair and Transparent Recruitment process.
