After that I have come to know that there are some irregularities in the recruitment. So I have filed the petition for the information through the RTI Act. If they deny to provide the information with the clause of third party. what will be the use of RTI act.

Any way I do not come under third party sine I have written the exam and competed in the exam. I have the right to seek the information. If this type of reply continues, the sanctity of the RTI will go off. If this continues, almost every RTI seeker will become third party and there will be no information provided through this act and all the irregularities committed will be legalized.

So I request you to order the authority to provide the details, since I do not come under the third party since I was on the contestant to the post.
