If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

1. Bidder should quote for all the items in the schedule
2. bidder should submit all the annexures as per tender document.
3. bidder should enclose all the documents as per eligibility criteria.

Note: The Successful Bidder should submit 10% of PBG for the items mentioned at the sl. No: 2,3 &4 of schedule -A and Validity of PBG should be 14 months.
