	9. As per the list of candidates selected for Junior Assistant the results published are not satisfactory as we could clearly see that in the waiting list the same name Gandepally S. Prakash application no. NF6/20/1199 mentioned twice in the waiting list. This clearly shows manipulation of information and breach of trust which is a non acceptable. Kindly furnish the details of this manipulation of the information with explanatory proofs.	OBC candidate is also eligible for UR positions, if the candidate competes / stands on merit basis. One candidate was considered under UR category waitlist on merit basis and was also considered under OBC category on reservation basis.
