My application is not screened for attending the written test. From the published data I got the reason as Experience not till date.</p> <p>In the online application i have clearly mentioned from and to dates of working experience. In the online notification there was no option in the experience column as Till date or still continuing etc. Thats why I entered my application date as last working day, which satisfies the required years of experience. Also I attached in the promotion OM in the online portal.</p>	<p>Yes, we received your request on 29.05.2020, by 12.04 P.M.</p> <p>The review committee has verified your application and given remarks as "Insufficient Experience". (Please refer point no. 7 &amp; 20 under the General instructions of the notification.)</p> <p>The 'reason for not screening' stated on the website is as follows: "He requires three years of experience. Experience certificate for 1 year (Wipro is provided). For the experience at IICT, he has provided only the office memo of 2020. He has written at the bottom of the office memo that he has been working there since 2016"</p> <p>As per the notification, Institute considered the Experience till last date of application i.e. 17.02.2020</p> <p>As per the General Instructions to the Candidates, OMs will not be considered as a proof of Experience. (Please refer point no. 7 &amp; 20 under the General instructions of the notification.)</p>

<p>I was initially not eligible to apply as per notification but later with the corrigendum notification. PG with 3 years experience. While scrutinising the applications the corrigendum eligibility might not be considered it seems. It is my personal opinion</p> <p>I am perfectly eligible as per the modified notification criteria. One of my colleagues and me applied for the same post and attached the same Promotion OM for the field of experience details. His application got screened and received hall ticket to attend the exam. His name is Rakesh Doure. His application number is 7112</p>	<p>As per the General Instructions, OMs will not be considered as a proof of Experience.
