Proposed DAPSC & DAPST w.r.t. SC/ST students:

- 1. To strengthen the SC/ST cell activities and continue to safeguard the special requirements of SC/STs
- 2. To conduct awareness sessions and encourage the SC/ST students to avail various scholarship / fellowships available for them in the Government.
- 3. To conduct awareness on the GoI initiation to promote overseas education for SC/ST students.
- 4. To continue liaison with the Ministry of Tribal Affairs on the GOAL program which aims at empowerment of STs through digital mode.
- 5. To conduct periodic interactions with students and build their confidence levels both on the personal and academic front.
- 6. To explore the various sources that can provide special remedial classes for academically weak SC/ST students.
- 7. To assess the reasons for heavy dropout rate of SC/STs and planning the way outs to curtail this.
- 8. To provide laptop / PC to all the SC/ST students on the lines of GoI scholarships.
