Rahim: Will the Minister of Education be pleased to state: (a) the annual permitted strength in the undergraduate, postgraduate and doctoral-level academic programmes in each Institutions of National Importance during the last five years; (b) the total number of students admitted in undergraduate, postgraduate and doctoral-level academic programmes in each of these institutions during the last five years, along with their SC/ST/OBC/EWS distribution; (c) the total number of vacant seats in undergraduate, postgraduate and doctoral-level academic programmes in each institution during the last five years, along with their SC/ST/OBC/EWS/Unreserved distribution; and (d) the details of the reserved seats which were de-reserved by each institution of National Importance during the last five years?
