#### **Appeal Text:**

### Dear Sir,

This has reference to my RTI application (IITHY/R/E/21/00070). Under guestion no. 1 I have requested for the guestion paper and the answer key, however, I have received the question paper and for answers key the below reply was furnished:

- Answer keys cannot be disclosed as it is not satisfying the larger public interest and as the question bank used for preparation of multiple-choice questions was limited. When the question paper can be shared through the RTI Act, as an applicant for the written exam I appeal and request you to provide the answers key also which will be useful for me in knowing my shortfalls. It may not be for a larger public interest – but as a candidate for the written exam I appeal for the same. If the information cannot be shared through the RTI Act, I request you to quote the rule (position) of the RTI Act where it mentions for the same.

Thanking you in anticipation of positive response as per the RTI Act.
