I have gone through your appeal with registration No. IITHY/A/E/21/00030, Dt.19.07.2021 and the reply furnished by the CPIO with reference to your RTI application cited above. Having examined the matter in detail, I sum up my observations as follows.

## **Grounds of the appeal:**

Provided Incomplete, Misleading or False Information.

### **Appeal Text:**

As per your reply you are saying the institute sent details timely. But please look into the below-attached document that Ministry rejected our scholarship on Date 17th Jan 2020 stating reason APPLICATIONNOT RECEIVED and institute sent the details on 16th Jan 2020 and 30th Jan 2020 how you are saying institute sent details timely as how the courier service will reach the ministry in one day. This clearly shows that delay is from the institute. And No details were provided for the recent academic year 2020-21. Please look into the matter.

#### **Disposal of Appeal:**

A. This Institute forwarded two sets of scholarship proposals (Fresh & Renewal cases) for the release of scholarships vide its office letters dated 31.12.2019, which was dispatched on 02.01.2020 via speed post. The details of dispatch are as follows:

B. In view of 'A' above, it is confirmed that the proposals were sent on 31.12.2019. However, during 2nd week we contacted one of the staff at MSJE over phone to check and confirm if they had received the proposals or not. The Ministry official asked to resend the documents once again. Hence, we re-sent the proposals vide letter dated 16.1.2020 for the second time.

C. The renewal proposals of 2018, 2017 & 2016 batches referred in 'A' at (iv) were separately bundled (year wise) and were sent together in a single packet (for 2018, 2017 & 2016). The proposals of 2017 & 2016 batches were processed and the students got their scholarships released but the Scholarship for 2018 batch were not processed by the MSJE (Ministry).

D. The Ministry sought the pending releases details vide emails dated 24.4.2020, 17.8.2020 and 9.9.2020 wherein we promptly provided all the details of pending payments vide our letters dated 25.4.2020, 27.8.2020 and 16.10.2020 respectively. If the Ministry had already rejected the applications, then there was no need to ask the Institute to provide the details of pending scholarships to enable the release.

E. On introduction of National Scholarship Portal, all the government scholarship agencies have insisted on receiving applications only through NSP and completely dispensed with the hardcopy proposals system. Though MSJE stressed on receiving applications through NSP only, there was an oral discussion in a meeting that they wanted hardcopy proposals only for the batches of pre-NSP regime. As such the 2018 batch students have applied in NSP and received their 1st year scholarship, their applications are already streamlined in the NSP portal. However, on the pretext that hardcopy applications are not received, rejecting the application of student does not seem valid.

F. As per Scholarship guidelines notified by the Ministry, the scholarship, once awarded, will continue till the completion of the course, subject to satisfactory performance of the student.

G. Accordingly, your appeal cited above stands disposed of.
