### **Appeal Text:**



1. Whether the institution has prepared such reservation rosters in each teaching cadre?
2. If yes, provide certified updated copies of the same. Mention the date on which it was adopted by your institution.
3. Whether the institution is preparing such reservation rosters in each teaching cadre? What is the tentative date for finalizing the rosters?
4. If yes, provide copies of the guidelines being used to prepare the rosters
5. If no, what are the reasons for not preparing the rosters as per the CEI Act-2019 ?
6. Whether these reasons were communicated to the Ministry of Education by your institution?
7. If yes, provide copies of the institute communication to the Ministry about the same, and responses, if any, to it from the Ministry.
8. If no, provide reasons for not registering your inabilities with implementing the CEI Act-2019 to the Government.
