- **1. ACKNOWLEDGEMENT:** Acknowledgement for the receipt of the Purchase order should be sent immediately through E-mail intimating the probable date of shipment. A formal order acknowledgement.
- 2. DELIVERY: The material should be dispatched within 28 29 weeks from the date of receipt of the Purchase Order. Please dispatch the items BY AIR on Freight prepaid basis for Customs Clearance at Hyderabad, Telangana State, India. The items may please be dispatched in the name of The Director, Indian Institute of Technology Hyderabad, Kandi, Sangareddy District, Telangana., India. Our Imports are under Open General License Scheme as applicable to us vide Import Policy for 2015-20 of Government of India.
- **3. Installation & Commissioning:** Installation & Commissioning, should be completed within one month of receipt of goods in IITH Stores, wherever applicable.
- 4. Warranty: 12 months from the date of Installation.
- **5. Payment Terms: 90% Payment will be made against delivery and remaining** 10% Payment will be released after Installation, Commissioning and acceptance of the end user faculty of IITH and submission of the invoices with satisfactory report the payment will be made via **Wire Transfer** for value through our Bankers viz. - 7. - **8. Liquidated Damages:** If you fail to deliver the goods by the stipulated date, a sum equivalent to 0.5% of contract value for each week of delay or part thereof until actual delivery will be deducted from the contract value, as liquidated damages, subject to maximum deduction of 10% of contract value. Once the maximum is reached, termination of contract may be considered by IITH.
- **9. Risk Purchase Clause:** If you fail to deliver the goods within the maximum delivery period specified, IITH may procure on such terms and in such manner as it deems appropriate. Goods or services similar to those undelivered and you are liable to IITH for any excess costs for such similar goods and services.
- 10. Penalty/Demurrage Charges: In case of demurrage/Penalty for delay in filing Bill of Entry due to wrong shipment papers, due to delay in intimation about the dispatch of shipment, Custom Queries or if the flight arrives on holidays (Sat & Sun) or any other reason not attributable to IITH and Custom Clearing Agent. The demurrage/Penalty charges will be borne by Supplier/Indian Agent

11. Arbitration:

- a) Unless otherwise specified, in all cases of disputes which cannot be settled by mutual negotiations, the disputes or differences shall finally be settled and binding on both parties by arbitration in conformity with the rules of Indian Arbitration and Conciliation Act 1996. All disputes or differences whatsoever arising between the parties out of relating to the construction, meaning and operation or effect of the general terms and conditions including the Purchase Order or the breach thereof shall be binding on the parties.
- b) Performance of the Purchase Order shall continue during arbitration and any subsequent proceedings.
- c) The jurisdiction and venue of arbitration shall be Hyderabad. The Arbitrator will be the Director, IITH or his nominee.
- **12. FORCE MAJEURE:** If the performance of the obligation of either party is rendered commercially impossible by any of the events hereinafter mentioned, the same party shall notice of 15 days from the date of such an event in writing to the other party (i) Government Regulations (ii) Legislation (iii) Natural Disasters (iv) Strikes (v) Lockout (vi) Act of God.
- **13. PACKING:** Kindly ensure that the material is well packed with a water proof paper or polythene sheet and suitably cushioned to withstand the rigorous of journey from warehouse to warehouse. All fragile items must be packed in suitable crates.
