- 1. It may kindly be noted that your bid should:
- a) Single Part
- 2. The acceptance of the quotation will rest with the competent authority, who does not bind himself to accept the lowest quotation and reserves the right to himself to reject, or partially accept any or all the quotations received without assigning any reason.

Accordingly preference will be given to the Make in India products while evaluating the bids, however, it is the sole responsibility of the bidder(s) to specify the product quoted by them is of Make in India product along with respective documentary evidence as stipulated in the aforesaid order in the technical bid itself.

- b) As per the above order and its subsequent amendments "Local Content" means the amount of value added in India which shall be value of the item procured (excluding net domestic indirect taxes) minus the value of the imported content in the item (including all the custom duties) as a proportion of the total value, in percent. Accordingly the suppliers will be classified in following categories.

- c) **Verification of Local Content**: The Class I Local Supplier /Class II Local Supplier at the time of bidding shall be required to indicate the percentage of local content and provide self-certification as per Annexure D that the items offered meet the local content requirement. The bidders can be debarred for a period up to two years as , per Rule 151(iii) of GFR 2017, in case of false declaration.

Complaint Redressal Mechanism:

In case any complaint received by the procuring agency or the concerned Ministry/Department against the claim of a bidder regarding local content/domestic value addition in a product, the same shall be referred to competent authority at IITH or the relevant Ministry.

The bidder against whom the complaint is received shall be required to furnish the necessary documentation in support of the domestic value addition claimed in the product to authority. If no information is furnished by the bidder, such laboratories may take further necessary action, to establish the bonafides of the claim

A complaint fee of Rs. 2 lakh or 1% of the value of the domestically manufactured products being procured (subject to a maximum of Rs.5 lakh), whichever is higher, to be paid by Demand Draft to be deposited with Procuring Institute. In case, the complaint is found to be incorrect, the complaint fee shall be forfeited. In case, the complaint is upheld and found to be substantially correct, deposited fee of the complainant would be refunded without any interest.

TECHNICAL SPECIFICATIOS

Technical requirements for image splitter system compatible with Nikon Ti Eclipse inverted fluorescence microscope.

- 1. The image splitter should be capable of splitting dual band emission spectra into separate channels, and project these onto a single camera sensor.
- 2. The image splitter should be capable of splitting/separating emissions in the range of 520/40 nm and 620/60 nm.
- 3. The image splitter system should come with corrector lens for aberrations.
- 4. The image splitter system should come with appropriate neutral density filters.
- 5. The image splitter system should have interchangeable emission filter / dichroic holders.
- 6. The system should be capable of bypassing emission without removal from optical path.
- 7. It should have rotating filter mount for polarisation studies.
- 8. The system should be capable of supporting large sensor cameras $-16.6 \times 14 \text{ mm}$.
- 9. It should have angled and flat auxiliary drop-in holders for neutral density filtering, polarisers or for chromatic correction.
- 10. It should support ultra-flat dichroic (2mm thick) for emission image splitting or TIRF use.
- 11. The system should have 450nm to 875nm coatings on all optical surfaces.
- 12. Overall the system should be capable of super-resolution microscopy.
