- b) As per the above order and its subsequent amendments "Local Content" means the amount of value added in India which shall be value of the item procured (excluding net domestic indirect taxes) minus the value of the imported content in the item (including all the custom duties) as a proportion of the total value, in percent. Accordingly the suppliers will be classified in following categories.

Complaint Redressal Mechanism:

Technical Requirements for the HPC Enabled CFD and Chemical Kinetic Development Software

The software must be a general purpose CFD solver that uses Finite Volume Method discretization method over unstructured mesh. It should be able to solve Navier Stokes equations for both incompressible and compressible flow regimes and should have modules to simulate:

- RANS and LES based turbulence models
- Heat transfer with phase change
- Species transport with volumetric, premixed, non-premixed and partially premixed combustion models. It should also be handle solid phase reactions
- Multiphase models including dispersed phase modelling, single and multi-fluid multiphase models

Software should have a sophisticated pre-processing tool to create unstructured mesh of industrial grade solid models. It should also have powerful post-processing tools to create contour, vector and particle track plots, x-y plots, statistical analysis and animations.

The CFD software must be able to perform RANS and LES based computational modelling of multiphase (solid, gas, liquid and interfacial) reacting turbulent flows specifically relevant to gasification, combustion, pyrolysis and fuel cell/battery cell systems. Specific high performance modules for handling flows of dense and dilute gas-solid, gas-particle as well as gas-liquid and liquid-solid phases desired.

The CFD software must be able to process CHEMKIN file compatible chemical kinetic files and incorporate them in reacting CFD simulations.

The CFD software must contain associated integrated reaction kinetic mechanism development, validation and optimization platform where reaction kinetic mechanisms associated with combustion, gasification, pyrolysis, catalytic and electrochemical systems can be developed, validated, optimized, reduced and incorporated into the CFD simulations. The kinetic mechanisms must CHEMKIN file compatible.

The CFD software must be parallelizable and must have at least 128 core HPC cluster enabling compatibility so that it can be run in supercomputing facilities located at IITH.

The CFD software must have user friendly mesh generating and data-processing/visualization GUI systems and modules incorporated into it.

The CFD software must have an extensive track-record of being used for the above purposes for academic and industrial research both in India and abroad and should be in extensive use in Indian and International Research and RnD Centers (necessary for satisfying current project requirements).
